Custodial parent/guardian agrees to pay the \$1,000 annual fee for the Optional Full-Day Kindergarten Program. For parents not submitting full payment, the following payment plan must be followed for the student to continue to be enrolled in the full-day kindergarten program:

\$300 Payment	August 9, 2017
\$300 Payment	November 1, 2017
\$300 Final Payment	February 1, 2018

\*Students are unable to start full-day kindergarten until  
the deposit & first payments are received.

**\*\*10% discount if \$1000 fee paid in full on or before August 9th, 2017.**

- We will accept a personal check, money order, MasterCard or VISA as payment. Checks and money orders should be made payable to Maumee City Schools. If your check is returned for non-sufficient funds (NSF), your account will be debited electronically for both face amount and returned check fees. Payments will be collected by the individual school buildings. *This program fee does not include student supply fees or school lunch costs.*
- No refunds will be made if the student is ill or absent from the program and no amounts will be deducted for school holidays which occur during the course of the program. **FAILURE TO PAY WILL RESULT IN THE CHILD'S REMOVAL FROM THE PROGRAM. THE CHILD WILL BE PLACED IN THE REGULAR HALF-DAY PROGRAM.**
- Students may qualify for reduced tuition based on their eligibility of the free and reduced lunch program. Those applications will be made available after August 1, 2017. The \$100 deposit is due June 1, 2017 for all students.
- The custodial parent/guardian of a child enrolled in the Optional Full-Day Kindergarten Program must be a Maumee City School District taxpayer and/or employee of the Maumee City School District in order for their child to attend the program. Further, the custodial parent/guardian understands that the Optional Full-Day Kindergarten Program is provided as a service and is not part of the state required educational program.
- A student **MAY BE REMOVED** at the discretion of the building principal from the Optional Full-Day Kindergarten Program if his/her behavior is disruptive to the other children enrolled in the program. Such behavior may include, but not be limited to physical aggressiveness toward other children and/or refusal to cooperate with teachers and other children. A conference will be held with the custodial parent/guardian, teacher and building principal if a concern arises which could result in the child's removal from the program. The custodial parent/guardian will receive written notification at least one week in advance of a child's removal from the program. Re-entry will be a building team decision.
- Any medical condition or problem, which might affect the above named child's welfare while in the Optional Full-Day Kindergarten Program, should be disclosed by the custodial parent/ guardian on the emergency medical card.
